**INSTRUCTIONS FOR FILING STATEMENT OF  
BUSINESS WITHDRAWAL, DISCONTINUANCE, AND/OR  
CHANGE OF RESIDENCE/BUSINESS LOCATION**

If you want to file a Business Withdrawal, Discontinuance, and/or Change of Residence/Business Location, please note the following:

- A change in the business name requires the filing of a new Business Certificate, signed by all new owners, and the termination of the old Business Certificate, signed by all previous owners.
- A change in the business location is a change that requires the signature of all owners.
- A change in an owner's residence is a change that requires the signature of that owner only.
- The withdrawal of an owner is a partial withdrawal that requires the signature of that owner only.
- The addition of an owner requires the filing of a new Business Certificate, signed by all new owners, and the termination of the old Business Certificate, signed by all owners.

For business withdrawal or discontinuance, complete the top portion of the attached form including business name, business address, date of original Business Certificate filing, full name, residence, telephone number and signature.

For Change of Business Location and/or Residence, complete the second portion of the attached form, noting the business name, date of Business Certificate filing, and new business/residential address.

**Please note that your Business Withdrawal/Discontinuance and/or Change of Resident/Business Location must be notarized.**
